



THE BETHANY NURSERY GROUP, INC ENROLLMENT CONTRACT

I. ENROLLMENT. I, _____ (parent or legal guardian), hereby enroll _____ (“Student”) for preschool school at the Bethany Nursery Group, Inc., (“the School”), a not for profit cooperative school operated as a community project, for the Academic Year 2025-2026 I, the undersigned, on behalf of the Student and myself, hereby agree to all of the terms and conditions of this Agreement, and to comply with all policies, regulations, and procedures of the School. This Agreement shall become effective as of upon signing, and terminate at the end of the contracted Academic Year. Tuition is payable at the times, and in the amounts, found on the attached tuition payment schedule. A processing fee of FIFTY DOLLARS (\$50.00) and an enrollment deposit (down payment) of TWO HUNDRED AND 00/100 (\$200.00) DOLLARS must accompany this Agreement. The \$200.00 will be deducted from the year’s tuition. Both fees are non-refundable.

Prior to the commencement of each Academic Year, each student must submit a completed health form and immunization record. Blank forms are available from the School. The forms must be completed by the student’s professional health care provider, and returned on or before September 1, 2025. Physicals are valid for one year after the examination date. Student immunizations must meet State of Connecticut Department of Public Health requirements.

III. _____ COOPERATIVE OBLIGATION. Any one parent or legal guardian of the Student is required to complete one work time activity per academic year per child enrolled. Failure to do so will result in a **\$50.00 fee**. The \$50.00 fee is due May 1, 2026 if the obligation has not been completed by this date.

IV. _____ DELINQUENT ACCOUNTS. Timely payment of tuition in accordance with this Agreement and of any other School fees is important to the operating budget of the School. I therefore agree:

- (i.)** In the event Bethany Nursery Group does not receive a tuition payment on or before the dates specified on the tuition schedule, **a late fee of \$25.00** will be assessed.
- (ii.)** I agree to reimburse the School for any bank fees incurred from checks returned in the processing of my account.
- (iii.)** The School reserves the right not to allow the Student to enter class or participate in school activities if tuition or other School charges for the student are unpaid or delinquent.
- (iv.)** In the event I fail to pay all Tuition, fees and/or other charges when due, the School may turn my debt over to an attorney or collection agency. In such event, I agree to pay all reasonable collection costs, including attorney's fees and court costs.

- V. **FULL-YEAR OBLIGATION.** I agree that I will pay the full amount required by this Agreement for the entire School year unless the School receives written notification of withdrawal by August 1, 2025. If my child begins after the start of the school year, I agree to pay the tuition from the start date through the end of the school year.
- VI. **ABSENSES/CLOSURES.** I understand that according to school policy, annual tuition is divided into monthly installments for easy payment purposes; therefore, I will not receive any discounts/refunds due to extended absences or school closures.
- VII. **INDEMNIFICATION.** I agree to release and hold harmless the School, its agents and employees from all claims, damages, or other liabilities for injuries to the Student which are not the result of gross negligence by the School, its agents or employees. I also agree to indemnify and defend the School from any and all damages caused by the Student.
- VIII. **RULES AND REGULATIONS.** I agree to accept all of the School's policies, rules and regulations.
- IX. **SCHOOL'S RIGHTS RESERVED.** The School reserves the right: (i) to insist upon immediate withdrawal and termination of contract, for any student or family member whose presence is considered detrimental to the Student, other students, or the School's best interest as determined by the school in its sole discretion, and (ii) to amend any term or provision of this Agreement by written agreement with the undersigned parent or legal guardian based upon such individual considerations and factors as the School may deem relevant, including financial conditions or otherwise. No amendment or agreement made by the School with any other person or student shall effect this Agreement between the School, the Student, and the undersigned parent or legal guardian. No amendment shall be valid unless it is in writing signed by all parties to this Agreement and the School.
- X. **ACKNOWLEDGEMENT.** This Agreement is a legal document. Our signatures are acknowledgment that we have read carefully and understand the Agreement's provisions. Changes to this contract can only be made by Bethany Nursery Group. Any changes made by other parties are considered null and void. We have been provided with the Behavior Policy, which has been reviewed.
